1. Terms of Use and Privacy Policy

This Privacy Policy governs the manner in which St Andrew's Club collects, uses, maintains and discloses information collected from users (each, a "User") of the https://www.standrewsclub.com website ("Site"). This privacy policy applies to the Site and all products and services offered by St Andrew's Club, through the Site.

2. Personal Data collected

2.1 the types of personal data that are collected

If signing up to the 'Join Us' membership part of the Site, Users will be asked for name, email address, mailing address, phone number, date of birth, medical conditions, allergies, emergency contact, additional information requested to help us with our funding applications, anonymised for analysis (detailed in 4.1 below).

If signing up to 'Newsletter' part of the Site, Users will be asked for name, email address, mailing address.

The Site does **not** store any payment card details, as these are all handled directly by PayPal. Here is their privacy notice:

Users can always refuse to supply personal identification information, although this may then prevent them from engaging in certain Site related activities.

We may collect personal data which indirectly identifies Users, whenever they interact with our Site. The personal data may include the browser name, the type of computer and technical information about Users' means of connection to our Site, such as the operating system and the Internet service providers utilized and other similar information.

2.2 how/when this data is collected

We may collect personal data from Users in a variety of ways, including, but not limited to, when Users visit our Site, create, use or manage an account on our Site, subscribe to the newsletter and in connection with other activities, services, features or resources we may make available on our Site.

3. Web browser cookies

Our Site uses "cookies" to enhance User experience. A cookie is a small file of letters and numbers which is put on your computer or mobile device when you access a website. Cookies are widely used in order to make websites or mobile applications work more effectively, as well as to store information about your preferences or past actions. Users' consent will be required for cookies to be enabled and Users can

refuse to provide this consent. Users' web browsers place cookies on their hard drive for record-keeping purposes and sometimes to track information about them. Users may choose to set their web browser to refuse cookies, or to alert you when cookies are being sent. If they do so, note that some parts of the Site may not function properly.

3.1 We use the following types of cookies

- 'Session cookies' which exist only why your browser is open. These are deleted automatically once you close your browser.
- 'Persistent cookies' which survive after your browser is closed. They can be used by the Site to recognise your computer or mobile device when you open your browser and browse the internet again.

4. How we use collected information?

4.1 processing under Article 13 UK GDPR (i.e. in relation to personal data collected directly from Users)

If a User creates an account on our Site, we will process the following information to manage the account, using the Optimiser database function to ensure:

- Users receive the communications they have opted into from the following:

 - Occasional short Club survey email/ text message/ post
 - o Chronicle e-newsletter up to 6 times per year email
 - Chronicle printed newsletter up to 3 times per year post
 - Occasional impact reports/fundraising appeals email/ post
 - Occasional event invitations email/ post
- Additional information requested to help us with our funding applications, is anonymised for analysis:
 - Learning Difficulties

- Other Disability
- Accommodation Status choose from a selection
- Ethnic group choose from a selection
- Education Status (if applicable)
- Training
- Name of School/College/University
- Religion choose from a selection
- If a User signs up to our mailing list, using the Optimiser mailing function communications will be sent out according to the preferences selected:
 - Chronicle e-newsletter up to 6 times per year email
 - Chronicle printed newsletter up to 3 times per year post
 - Occasional impact reports/fundraising appeals email/ post
 - Occasional event invitations email/ post
- If at any time the User would like to unsubscribe from receiving future comms, we include detailed unsubscribe instructions at the bottom of each email/ text message or the User may contact us via our Site.

4.2 processing under Article 14 UK GDPR (i.e. in relation to personal data collected from third parties).

St Andrew's Club may collect and use Users' personal data, which is passed to St Andrew's Club anonymously, for the following purposes:

• To provide information about how visitors use our Site, which we can then use to compile reports and to help us improve our service.

5. How we protect your information

We comply with UK GDPR data collection, storage and processing practices and security measures to protect against unauthorised access, alteration, disclosure or destruction of your personal data, including your username, password, transaction information and other data stored on our Site.

6. Sharing your personal information

We do not sell, trade, or rent Users' personal data to others. Our website, database and mail marketing function is hosted by Optimiser, which will not transfer European Data to any country or recipient not recognized as providing an adequate level of protection for Personal Data (within the meaning of applicable European Data Protection Laws), unless it first takes all such measures as are necessary to ensure the transfer is in compliance with applicable European Data Protection Laws. Such measures may include (without limitation) transferring such data to a recipient that is covered by a suitable framework or other legally adequate transfer mechanism recognized by the relevant authorities or courts as providing an adequate level of protection for Personal Data, to a recipient that has achieved binding corporate rules authorization in accordance with European Data Protection Laws, or to a recipient that has executed appropriate standard contractual clauses in each case as adopted or approved in accordance with applicable European Data Protection Laws.

We may use third party service providers to help us operate our business and the Site or administer activities on our behalf, such as sending out surveys. We may share your personal data with these third parties for those limited purposes provided that you have given us your permission.
